Tips to track your expenses, mileage, payments received

As a volleyball official, managing your schedule and tracking your expenses is crucial to ensure smooth operations and accurate financial management, including tax records. Utilizing effective tools, such as Microsoft Excel, Google Sheets, Mac Numbers, or other similar software, can greatly simplify and streamline these processes.

Here are some tips on how to efficiently track your schedule and expenses using these tools. Several officials have shared their spreadsheet as examples of how to track. Thanks Rick Jones, Shane Hubred and others for helping with these tips.

1. Create a Schedule Template: Creating a schedule template in Excel, Sheets, or Numbers can be a valuable tool to keep track of your upcoming games, record your expenses and mileage and whether you have been paid. You can customize the template to suit your needs, including details such as match dates, locations, start times, match counts, miles traveled, and officiating fees. Use conditional formatting or color-coding to easily identify important information, such as conference,

Tips for officials who seek to advance

As officials look to advance to their next level of certification - whether it be from Regional to Junior National or Junior National to National ratings, the little nuances of officiating come into play.

At right are tips that all officials can use to better assist their partners and help the game run smooth.

Notes & Points of Emphasis for Candidates

Match preparation:

- Check equipment (antenna alignment, etc); ensure court is clear
- Roster check Libero jersey contrast uniform check (must be worn or visible on bench) Jewelry long, dangling necklaces (&/or medallions); large, hoop earrings
- Working with scorers:
 - Location of score table (space for R2 to transition move if needed; no "extra" players around table) "Ready" signal from scorer (after subs & noting next server), and Libero in/out from asst scorer R2 should visually note Libero in/out when time-out is called, then confirm with asst scorer
- Working with line judges:
 - Know when to look for information vs when to look to affirm a decision
 - When ball is close, "check in" with your line judge(s); keeps them in the game
 - Clearly in/out/touch, signal while confirming (quick glance) with LJ

Game awareness:

- "Feel the room" Appropriate calls? Too tight for level of play? Missed something obvious? Use all your senses to conduct the match Interference decisions for errant ball, etc.; not automatic replay – know where the playing action is
- . happening; replay may not be necessary

Injury Situations:

 Know the team's/coach's options: "reasonable amount of time", sub, time-out, Libero, exceptional sub
 Study USAV 17.1, also 15.7; also Blood & Concussion Guidelines (page 208, 2021-2023 Rulebook) Mechanics/Signals

- Review pgs 104-116 in 2021-2023 Rulebook R2 controls substitution procedure, the substitutes do not; they must pause at sideline No display of time-out info at end of time-out

- Centering at end of rally; proper timing & duration Whistle use do not overlap whistle with a signal (beckon or loss of rally)
- No "safe" signal (back-row plays) if no one questions the play Avoid "walking help signals" by R2; R1's view of help signals not obstructed by net pole

Second referee transition:

- Typically transition on contact of serve; do not lag or wait for first pass
- Start closer to extension of centerline on serve receive (but not behind net pole) Suggestion: Be on blocking team's side BEFORE setter makes second contact
- Know when fast, tight net play means you should stay in position instead of transitioning

Second referee:

- Have confidence & a presence; be assertive (with information) when needed
- Supporting R1 decision vs getting call right for the teams know the difference Signal tempo when calling a fault whistle & ensure play has stopped before signaling fault

Net play

- USAV National Clinic (2019): nearly 80% of 4-hits (2-hits) calls are touched by the blocker focus
 ahead of ball at net plane; more forgivable to allow play to continue than to call "4 hits" in error
- Back-row faults pay attention to height & position of ball and the "reach" of the back-row player

Game awareness:

- "Feel the room" Appropriate calls? Too tight for level of play? Missed something obvious? Use all your senses to conduct the match . .
 - Interference decisions for errant ball, etc.; not automatic replay know where the playing action is happening; replay may not be necessary
