- 4 Staff will need to deal with the fallout
- 5 Logistics
 - Current proposal came from committee. This would need to be voted down and a new proposal would need to be made
 - If voted down, a new proposal would come in new business

6 Questions?

- If voted down, what if a club does a summer tryout anyway
- Review the current "sanction" list currently a "Warning" (doesn't make an impact)
 - Any member participating in tryout outside the tryout period is breaking the rule not just the club
- Tracking Document logistics of creation/tracking. Example exists in Iowa/North Texas (electronic)
- Board time spent talking tryouts is not in the best interest of serving all members
- This topic should not be about talent, but rather total member(ships); our goal is to keep the members in Badger Region/USA Volleyball
- Is this hurting or helping Wisconsin Volleyball?
- How we frame/publicize/share the information with all (not forcing summer tryouts)
- Regardless of what the tryout policy is we will be both helping and hurting members
- The focus should be more on the athletes/families and less on the clubs (clubs will find a way to find athletes)
- Many clubs main focus is participation, not necessarily talent/results focused
- Concern with retention occurring during season (can we wait until the season is over)
 - ♦ If the club decides to issue retention while their teams are still competing, that's their call

- 1 BOD should not share, talk about with others; let BOD make the press release
- 2 Clubs should share official Badger Region press release
- 3 What needs to be shared and timeline of:
 - Develop the commitment form (electronic tracking)
 - Update policies, manuals, and handbooks on website
 - Alter retention period
 - Summer open houses
 - Marketing, PR, Rationale focus will be POSITIVE
 - When will this be re-visited? 2 years
 - Did we re-visit retention policy change?
 - Retain coaches, facilities (8 months away)
 - Club contact policy will need to be reviewed (families can always reach out; when can clubs?). Clubs can run "training" clinics/open gyms at any time
 - Review the Last Second Chance Tryouts timing
 - Does there need to be a first allowable practice date for 14 & under? No
 - Region to re-establish the Gold/Silver/Bronze seal tiers for clubs on our website
